

There are inherent risks, dangers and hazards in adventure activities. We will Endeavour to make your trip as safe as possible, but not all risks, dangers and hazards can be anticipated or avoided. All of us that do them accept them. If you can't, please stay at home. As individuals, everyone must calculate the dangers, judge for yourselves, and decide accordingly. From the moment you step out of the apartment door.

1. INSURANCE

Everyone booking an EAZY RIDERZ holiday must be insured. You must show proof of suitable insurance cover. If, on arrival in the resort, you are found to have insufficient cover you will be obliged to purchase a suitable insurance policy.

2. DEPOSITS AND PAYMENTS

A deposit of £50 per person is required at the time of booking. The final balance of payment is due 10 weeks prior to departure. If final payment has not been received by this date, the booking will be treated as a cancellation and the deposit shall not be refunded. Should the booking be made within 10 weeks of the date of departure, the full amount is payable immediately. No contract shall exist between EAZY RIDERZ and yourself until the payment has been received.

A security deposit of £100 per room is taken at the beginning of the holiday, this is returned in full at the end of your holiday, providing nothing has been damaged or stolen.

3. CANCELLATIONS AND CHANGES

By EAZY RIDERZ - In the unlikely event of EAZY RIDERZ having to cancel/change your holiday details you will be notified as soon as possible and will have the choice of the following, as applicable:

A - accepting the change.

B - Accepting an alternative holiday with us at no extra cost.

C - Cancelling your holiday, in which case we will offer you a full refund.

By you - If you change any of your flight details after having booked your holiday, an administrative charge may be incurred which will then be passed on to you. If you are obliged to cancel your booking you must inform EAZY RIDERZ in writing immediately to info@eazyriderz.com. In all cases your premium and deposit will be forfeited and you will become liable for charges on the following scale:

Over 10 weeks before departure date - deposit only

4 - 10 weeks before departure - 50% of holiday cost

Under 4 weeks before departure - 100% of holiday cost

4. BEHAVIOUR

Whilst on EAZY RIDERZ property all clients are expected to behave in an orderly and acceptable manner. Should their behavior threaten the condition of the accommodation or seriously impair the enjoyment of other guests, EAZY RIDERZ reserves the right to refuse to further accommodate the guilty party and contractual obligations will be terminated. The guilty party will be liable for the cost of any damage so caused.

5. RESPONSIBILITY

In the event of death or personal injury to yourself or any of your party traveling with us under your booking we do not accept liability if such death or personal injury is not through any fault of ours or our supplier. In particular we do not accept responsibility if the death or personal injury is caused through no fault of ours or our suppliers or is due to circumstances which we could not reasonably foresee or have avoided.

You agree that if you have a claim against us which is the fault of another party that in the event of our dealing with your claim those rights that you have against the other party are transferred to us or our insurers.

6. POSSESSIONS AND LUGGAGE

EAZY RIDERZ will not be held responsible for any theft or loss of personal possessions from our premises / vehicles. Whilst we will endeavor to ensure the security of personal possessions of the party, we cannot guarantee it. Please be aware of this fact and leave expensive / personally valuable items at home.

7. SMOKING POLICY

We operate a strictly no smoking policy in all our vehicles and inside our accommodation facilities. If people wish to smoke they must do so outside of these areas. If it is found that you have smoked within our accommodation you will be liable to a cleaning charge of up to £200.00

8. CHECK IN/OUT TIMES

On arrival your room will be available after 2pm, on departure day you must vacate your room by 10:00am. If required storage facilities for luggage will be provided on departure day.

9. VISAS/PASSORTS

It is your responsibility to be in possession of a valid passport and/or any visa necessary. If you do not have a British or EC passport, please be sure to check visa requirements for the countries you will be visiting.

Remember, most flights are to Geneva in Switzerland which is not an EC member.

10. FREE ON PISTE HOSTING

Our ski hosts are not professional ski guides in that they do not hold a ski guide qualification or have the necessary insurance to cover you. Please insure your own policy covers you for winter sports.

During your stay you have the option of choosing our on-piste hosting free service. On-piste hosting consists of map orientation and guiding on marked pistes in the Portes du Soleil region. Under no circumstances will our hosts offer out bound / off piste guiding and if you choose to do this whilst in the company of a host you will be strongly advised against any such action unless you employ a Professional mountain guide and the appropriate equipment. Should you choose to ignore our advice, you assume all responsibility for your actions and the inherent dangers of off piste skiing / snowboarding.

We reserve the right at our absolute discretion to terminate without notice and liability “On piste hosting ” of any person whose behaviour is such that is likely, in our opinion, ski lift operator or ski guide or other person in authority to cause distress, danger, damage, or annoyance to other customers, employees property or to any third party.

11. TRANSFERS

If you book your transfer through us it will be provided by EAZY RIDERZ or possibly a 3rd party partner. (We only use companies which are fully insured and licensed)

- All of your inbound and outbound flight details must be sent to us at info@eazyriderz.com 30 days before departure.
- Payment is required for the transfer at the time of booking. It is possible in certain cases for only a deposit to be made. All deposits are strictly non refundable.
- If you wish to cancel your transfer, you must do this before 14 days before you travel and you will receive a refund with the exception on your deposit which is normally 50% of the total cost. If you cancel after this period all monies will be non refundable.

- You will be met at Geneva Airport upon arrival by an Eazy Riderz representative. They will co-ordinate your departure from the airport and get you quickly on your way to Morzine.
- As with our current transfer program you may be required to wait up to one hour in the coffee bar.
- If your flight is delayed and you miss your transfer, you will be allocated a seat on the next available transfer.
- If for any reason Eazy Riderz are unable to provide your transfer you will be transferred by a third party. In this instance it will only be by an organization that we have approved.
- All transfers are provided to and from Geneva Airport only. This includes hotels that are on the service roads alongside the airport. For example Crown Plaza, Express Holiday Inn. If your hotel falls outside this range you will be required to take the Hotel free shuttle bus to the airport to arrive at your pre-arranged arrival time. Please check directly with EAZY RIDERZ as to whether you can be picked up from your hotel.
- It is the responsibility of the customer that all the information on their Eazy Riderz booking confirmation is correct. Eazy Riderz accepts no responsibility for incorrect information given by a customer that results in either a flight being missed or a driver failing to be at the arrival airport in question to pick-up up a customer(s).
- On clear days the normal transfer time from Geneva to Morzine is 1hr15mins. Due to extreme mountain conditions during the season this is not always possible. Therefore occasionally we have to allow 4+ hours to transport you safely back which includes adequate time to check-in.
- We will always allow adequate time to get you safely and on time to the airport. However, there can be unforeseen exceptional circumstances that mean you miss your flight or train. Please note that for any costs incurred you will need to claim against your holiday insurance. We will provide any paperwork required to support your claim.
- It is the responsibility of the customer to direct the driver to their accommodation once in resort. The driver may know the specific accommodation, and in this case you will be taken straight there. However in the case that neither customer nor driver know the exact location of the accommodation the driver will drive round for up to 10 minutes trying to find it, but after that will have no option but to leave customers at the resort's tourist office (whether it is open or closed).

- Customers are limited to two items of luggage (one usual holiday luggage bag and small hand luggage bag), and a ski or snowboard bag. Any excess luggage must be declared at the time of booking. In the event of a client having excess luggage, Eazy Riderz reserves the right to charge an excess baggage allowance, or refuse to transport the items.
- Eazy Riderz reserves the right (and delegates to its drivers the right) to refuse to carry any person who is thought to be under the influence of alcohol or drugs and/or whose behaviour is considered to pose a threat to the chauffeur, the vehicle or the other passenger(s).
- Customers who soil the interior of a van due to excess alcohol consumption, or drugs are liable to a on the spot fine of 50 Euros. This fine is payable immediately to the Eazy Riderz driver. Customers who damage the vehicle in any way will liable to pay for the damages immediately.
- Passengers are not allowed to take onto our vehicles any alcoholic drinks for the purpose of consuming them, or to drink such drinks on our vehicles. Smoking is also not allowed in our vehicles.
- Eazy Riderz will use every reasonable means to ensure that the vehicle(s) arrives on time to begin the period of hire and that it reaches its destination on time. Eazy Riderz will not incur any liability whatsoever in the event of any delay due to causes beyond its control.
- If Eazy Riderz fails for any reason within our control to deliver its passengers to their confirmed destination, Eazy Riderz will provide suitable transport such as another coach, train, private car, taxi etc. Any reimbursement made by Eazy Riderz for the costs of an alternative means of transport incurred by the passenger to get to their ticketed destination shall be no more than the cost of getting to that destination by taxi.
- In the situation that the customer is not at a specified point at the arranged time (excluding flight arrivals), and Eazy Riderz have not previously been informed, the driver will not wait for the customer. In the situation that the customer is not at a specified point at the arranged time (excluding flight arrivals), and Eazy Riderz have been informed, the driver will wait for a MAXIMUM of 5 minutes (shared transfers), and a MAXIMUM of 10 minutes (private transfers).
- In the situation that a customer orders a special seat for their child or baby, Eazy Riderz will supply this seat free of charge. The seat will be allocated to the customer on the basis

of the weight group that they have informed Eazy Riderz that each child will be between at the time of travel. Eazy Riderz will bring a seat on the transfer that is kite marked to be suitable for a child of said weight. In the case that there is any dispute over the suitability of the chair Eazy Riderz will not be held accountable for difference of opinion. To save this occurrence, parents are recommended to bring their own child seats if there is any confusion.
